

## LIFETIME STATUS ELIGIBILITY AND DECLARATION

### WHAT QUALIFIES YOU AS A LIFETIMER?

Marram Community Trust Board of Trustees, at its absolute discretion, agrees the following criterion with regard to an employee's eligibility for consideration as a lifetimer of Marram Community Trust.

Outlined below is the current eligibility for a Lifetime Status. This criterion replaces all previous criteria that were in place before 11 February 2009.

From 11 February 2009, an employee must have left employment with an affiliated organisation and had five years service with affiliated organisations, with the last two years having continuous contributions.

An exception is – if any employee has been dismissed, they are not eligible for lifetime status.

### WHAT IS AN AFFILIATED ORGANISATION?

**An affiliated organisation is defined as:**

- (a) A subsidiary or successor organisation of New Zealand Post Limited, ANZ National Bank Limited or Telecom New Zealand Limited, and meets one of the following criteria:
  - (i) A pure acquisition of one of the above organisations (50% or more of the interest changed hands).
  - (ii) An organisation must have purchased assets and hired staff directly from a subsidiary or successor organisation.

**Or**

- (b) An affiliated organisation must be in a joint venture with New Zealand Post Limited; ANZ National Bank Limited; or Telecom New Zealand Limited; or a subsidiary or successor organisation.

**And**

- (c) Be approved at the discretion of the Marram Board of Trustees.

**And**

- d) Must enter into a relationship agreement with the Marram Community Trust, which clearly defines the expectations of the organisation, and the Marram Community Trust.
